Message from the Health Commissioner Dr. Terrence L. Holman, DVM, RS:

Agricultural Exemptions

As more and more farms are being purchased and operated away from home, many of our agricultural barns are seeing a need for restroom facilities. With bio-security threats, more barns need hand sinks and showers installed. Although there are exemptions for agricultural barns in some instances in regards to zoning, construction, and some plumbing, there are no exemptions for obtaining the proper permits that are required through the local health department.

Any building with a sink used for handwashing, human consumption or use, such as dishwashing, a toilet or a shower, is under the jurisdiction of the local health department. This includes the installation of a septic system, an approved potable water source, and plumbing. This is also the case with any installation of a toilet or a shower. A plumbing permit must be obtained by a registered plumber in Darke County. If the barn is commercial, a commercial plumber must do the work. If water will be used for animals only, then a plumbing permit is not required. Proper handling of the waste is still required.



Any water usage for humans must come from an approved, potable water source. Therefore, the well serving the barn must be a private water well and a water sample will need to confirm the water is safe. The well must meet all private water well requirements, including distances. In some cases, the well may be required to be an Ohio Environmental Protection Agency (OEPA) well.

All wastewater from a handwashing sink, toilet, or shower must go to an approved sewage treatment system or sanitary sewage system. Human sewage and excreta is not allowed to mix with animal waste and cannot go to the same system approved for animals. Soil testing must be done to determine what system will work best for the conditions. A holding tank can only be installed in circumstances where no other options exist and can only be permitted through the OEPA.

Because of distance requirements and soil testing, it is best to visit the local health department prior to building if you plan to install a hand sink, restroom, or shower facility.

Flu Season is Near... Know the Facts!

What is the difference between a cold and the flu? The flu and the common cold are both respiratory illnesses but they are caused by different viruses. Both illnesses have similar symptoms making it difficult to tell the difference. People with colds are more likely to have a runny or stuffy nose. In general the flu is worse than the common cold and symptoms are more intense. The flu can have very serious complications, such as pneumonia, bacterial infections or hospitalization.

How can you tell the difference between a cold and the flu?

Both the flu and common cold can cause fever, chills, cough, sore throat, stuffy nose, body aches, headaches. And fatigue. Cold symptoms are generally milder than flu symptoms. Tests can be done within the first few days of an illness to determine if a person has the flu.

Why should I get the flu shot?

The flu shot can help protect you from getting the flu. People who are very young, pregnant, elderly or have a weak immune system can become extremely ill from the flu. These people sometimes cannot get the flu shot, and rely on the people around them to stay healthy. Even if you are not at a high risk of severe complications, the flu shot will not only protect you, but also the people who cannot receive the flu shot themselves.

While listening to needs and concerns, they empower parents to make their own decisions about what they feel is best for themselves and their baby.

2018 Draft Fees

The Darke County Board of Health establishes fees for our services. These fees are authorized by Senate Bill 136 and House Bill 700 Section 3709.09 of the Ohio Revised Code. These fees will be reviewed for the second and third final readings at the Board of Health meetings held at the Darke County Health Department, 300 Garst Ave. Greenville. The meetings are: Tuesday, November 14, 2016 at 9am. Tuesday, December 5, 2016 at 9am. Visit our website to see the proposed fees.

Contractor Registration

The Darke County Health Department registers contractors such as Sewage Treatment System Installers, Service Providers, Pumpers, Plumbers, Sewage and Water Line Installers, Plumbing Appliance Installers and Water Haulers. The Health Department assures the contractors are insured and bonded and inspects the trucks if needed and their work when we are called out to a job site. Often times work is done without the Health Department being present on the job.

We strongly recommend homeowners ask around to find out who may be recommended (the Health Department does not recommend any contractors, we only provide a list of who is registered to perform the work in the county) and ask for estimates.

We often receive complaints that homeowners are not satisfied with work that has been done. Some homeowners are also signing contracts which may include Service Providers coming to the job multiple times a year and the homeowner being charged for every visit. Be sure not to sign anything unless you are clear what you are signing. Be sure to know what work is being performed and look at the work after it is completed. If it doesn't appear that the work was done correctly, please inform the contractor and call the Health Department if necessary so we can come and review the work that has been done. If you are unsatisfied, you should contact the Better Business Bureau at www.bbb.org. If you have damages, you will want to contact a lawyer to begin a civil action against the contractor's bond. The Health Department is not responsible for damages done or for contract agreements between the homeowner and the contractor
