There is a mandatory penalty fee of 25% of the renewal fees for operating a food service operation or a retail food establishment without a license after the deadline. (Chapter 3717 of the Ohio Revised Code)

\*\*\*Some food facilities may require a water sample of a private water well

Plan review fee is 30% of the county license fee based on risk level

The operation permit fee for experimental systems will be based upon the type of system and the number of inspections necessary to complete the operation permitting requirements or a service contract may be required.

For existing septic evaluations for home sale, landsplit- NO CHANGES will be made on the O&M program, including discount on fee &/or changes to the monitoring period. However, if warranted, we can reduce the cost of the inspection. For example, if the O&M has been completed within the last year by a Sanitarian, we can reduce the cost of the application fee by removing the septic evaluation fee. Note: H/O will still need to have the tank pumped if it has been over a year since that was completed.
